Dear Sir/Madam,

As you may be aware, training of the Government employees is guided by the National Training Policy, 2012. The NTP requires each Ministry/Department to develop a professional, impartial and efficient civil service that is responsive to the needs of the citizens.

- 2. Ministries/Departments are expected to appoint training managers, create a training cell, develop cadre training plans and annual training plans. They are also required to formulate new scheme to ensure that suitable training is imparted for its employees and cadre.
- 3. As you know, Training Division, DoPT runs a plan scheme of Domestic Funding of Foreign Training (DFFT) wherein officers are sent on foreign training. Funds availability under this scheme has stagnated, making it difficult for DoPT to fund the officers of other cadres, who are not on central deputation under the Central Staffing Scheme of DoPT, for various long and short term programs abroad.
- 4. I am, therefore, desired to request that you, being the cadre controlling authority, may devise scheme of foreign training for the officers of your cadre considering their specific requirements, subject to concurrence of DoPT. Training Division, DoPT will provide assistance in developing the scheme, as well as in identifying the programs, if required. A copy of existing guidelines on DFFT is attached for your guidance.
