**Minutes of the meeting with Ministries/Departments on the implementation of Bhavishya
held on 19/01/2017 at 3.00 P.M**

In order to implement 'Bhavishya' mandatorily w.e.f. 01/01/2017 in all Ministry/Department including attached/subordinate Offices; a review meeting was convened under the Chairpersonship of Additional Secretary, DoPPW with the following departments/offices:

- (i) Ministry of Culture
- (ii) Department of Health & Family Welfare
- (iii) Ministry of Road Transport & Highways
- (iv) Ministry of Shipping

2. The list of participants is at annexure -I.

3. Current Status:-

- Ministry of Culture - Out of 4 PAOs, only 1 PAO is registered. Out of 119 DDOs, 93 DDOs are yet to be registered.
- Department of Health & Family Welfare – Out of 11 PAOs, 9 PAOs are registered. Out of 155 DDOs, 97 DDOs are yet to be registered.
- Ministry of Road Transport & Highways – Out of 12 PAOs, only 3 PAOs are registered. Out of 72 DDOs, 44 DDOs are yet to be registered.
- Ministry of Shipping – Out of 5 PAOs, 3 PAOs are yet to be registered. Out of 55 DDOs, 49 DDOs are yet to be registered.

4. After reviewing the status of the above mentioned Departments, the following action points have emerged:-

a. The representative of Ministry of Culture and ASI has mentioned that all their 4 PAOs have been registered while 4 DDOs out of 14 non - registered DDOs of PAO (Culture, New Delhi) have to be deactivated as they are not dealing with salary matters. Beside this, they assured the chair that NIC Email creation has been completed and the remaining DDOs will be registered very soon. After this, they need training. The chair emphasized the need of simultaneous exercise i.e., registration as well as training. Data reconciliation will be done.

Action: DoPPW & NIC - DoPPW.

b. No one has attended the meeting from M/o Health & Family Welfare. However, the representative of CCA has mentioned that all the 11 PAOs have been registered. Additional Secretary has desired for a D.O letter to JS (Admn.), M/o Health & Family Welfare mentioning the non - arrival of any officer from the Ministry side for the meeting. However, the status of PAO registration will be technically verified.

Action: DoPPW & NIC- DoPPW.

c. The representatives of M/o RTH and M/o Shipping have mentioned that their DDOs are not able to register themselves due to non – availability of NIC-mail. However, they have applied for the same.

Action: M/o RTH and M/o Shipping.

d. At last, Additional Secretary has asked for a D.O letter to all Secretaries; requesting them to direct their Nodal Officers to take regular review meeting with their stakeholders on BHAVISHYA.

Action: DoPPW.
